"Looking back, looking forward"

Without our founding members, housing co-ops wouldn't number in the hundreds today. And without those members who have joined us since, our movement would not have consolidated and grown as it has. As some housing co-ops enter their fifth decade, they are considering the role of founding members while making room for newer members to feel that they have a role to play in a co-owned co-operative housing enterprise.

To recognize the role of newer members we are offering ten free conference registrations for members who have lived in their housing co-ops for less than 12 months, if they attend with at least one full-day paying registrant from their co-op. Make sure you indicate that you want to apply for this when you register – it will be given to the first ten housing co-ops who ask for it!

CONFERENCE DETAILS

Conference cost

Full-day rate: \$175*

Half-day rate: \$130* (9:30am - 1:30pm or 12:30pm -

4:45pm)

* GST will be added.

CHF BC will invoice your co-op after the conference. When you register online, you will be asked to confirm that your co-op has authorized your registration.

Buy 5 get 1 free: For every five full-day registrations, get one full-day registration free.

Early: Register by Friday, October 13, and save \$10 off each full-day registration fee.

Island: Each Vancouver Island co-op is eligible for a \$75 travel discount.

Free: Member co-ops in the Thompson Okanagan and Kootenay regions are eligible for two free registrations and one free hotel accommodation (book by October 13 to ensure a room booking).

*Lower Mainland Outliers: If your Lower Mainland co-op is more than 35 km from the Westin, take a further \$10 off each full-day registration fee.

*Bring a new member for free: Bring one member who has lived in the co-op for 12 months or less for no extra charge! Limited to the first ten co-ops that apply - so hurry!

Cancel by noon on Friday, October 20. If not, we will invoice your co-op. Workshops with fewer than 10 people registered may be cancelled.

Morning Workshops 9:30am - 12:30pm

1. YIKES, I'M THE SECRETARY

NEW

With a focus on the three areas of corporate records, meetings and co-op communications, this workshop will provide an overview of the board secretary's main responsibilities. Feel confident in the role of secretary so that you can enjoy the position rather than be overwhelmed by it.

2. DEALING WITH DEMENTIA

Is someone you know showing signs of cognitive changes? Would you like to know how to help? Join us to learn what dementia is and how to recognize common signs of the disease. We'll share examples of typical situations your co-op may face and discuss strategies for dealing with them.

3. ASK THE LAWYERS

Bring your toughest legal questions for our team of experienced co-op lawyers. Get the answer to that question you've always had about the Co-op Act, model rules, human rights, privacy, membership termination, governance, etc. Win a prize for the workshop's toughest question!

4. THE ART OF FACILITATION

Knowledge of subject matter and a good agenda are powerful assets for effective meetings. But facilitation, more of an art, is knowing how to leverage group dynamics so that meeting productivity and participant satisfaction are at their peak.

Governing a healthy housing co-op and overseeing its management demands a high level of diverse skill and knowledge. Good news - not everyone needs to be able to know, and be able to do, everything! Get ideas for how to offer learning opportunities, and start a plan for educating your membership.

You need skilled professionals to get great maintenance results, but there is still a critical role for members in looking after your property and buildings. 7. CANNABIS IN CO-OPS NEW

In 2018, new federal legislation regarding growing and using cannabis will come into effect that will have implications for housing co-ops. Learn about issues like electricity consumption, unit damage, users with disabilities and how to balance the rights of cannabis consumers with those responsibility your co-op has for dealing of non-consuming neighbours.

8. HOARDING UPDATED

Hoarding is an issue that affects many people and impacts the hoarder's life as well as those who live with or around them. Covering legal, safety and mental health perspectives, this panelworkshop will outline the problems that can be created, and clarify the with them.

9. HOW TO SAVE WATER, **ENERGY AND MONEY NEW**

Focusing on the most recent energy and cost-saving opportunities available for multi-family buildings in BC, we'll look at how to save more energy, water and money with free government and utility company programs.

10. A HEALTHY CO-OP NEW

Conflict is inevitable. It can be triggered from anywhere: hurt feelings, hostility between neighbours, misunderstandings, lack of information, poorly run meetings, contractor performance issues...the list goes on. This workshop will help you manage those challenging situations, constructively, and with long-term relationships in mind.

11. CO-OP HOUSING BASICS

Perfect for newer members, and notso-new members responsible for newmember orientation, this workshop will review everything that makes a housing co-op unique. Covering a brief history and the basic legal framework, as well as the distinct roles of members, boards, committees and staff, this workshop covers all the basics you need!

12. PRIVACY INFORMATION PRIMER FOR CO-OPS

Co-ops deal with a lot of personal information about members. BC's Personal Information Protection Act (PIPA) includes very specific rules about how this information can and can't be used as well as who should have access to it. Don't let a privacy complaint be the first time you discover PIPA.
