Our workshop program focuses on best practices to ensure the health of our co-ops as thriving businesses and vibrant, caring communities. We work hard to serve the needs of our existing members, but what about the many thousands of people who don't yet have a safe, affordable place to call home? Our theme last fall was *Looking Back, Looking Forward*, and this time we're *Looking Inward, Looking Outward*. In the afternoon we will ask the question: are there opportunities to increase our impact on affordable housing, one of the biggest issues Canadians face?

WORKSHOP DETAILS

Morning Workshops 9:30am - 12:30pm

1. CHAIRING: THE GATEWAY TO GOOD GOVERNANCE UPDATED

We ask members to make big decisions about their co-ops at general meetings. The right chairperson will make sure that meeting business gets done and that the process is fair and legal. Take home some great chairing tips and have fun with chairing role play!

4. MAKING MEMBER MANUALS MEANINGFUL NEW

Starting with the concept of the "howto" book, we will explore the member manual as an opportunity to demystify governance, clarify process and build community. Lets' re-imagine this manual as a tool to empower both new and longstanding members to become fully engaged in your housing co-op.

2. EDUCATING YOUR CO-OP UPDATED

Explore the Why, Who, What, and How of effective education. Complete an education strategy template and leave with a sample education policy and education committee job description. Be ready to support your co-op's goals through identified learning opportunities.

5. TURNING POINT UPDATED

By 2020, most housing co-ops in BC won't have an operating agreement with government. Scary? Not really. Join us for a look at what to expect, what to plan for, and the resources available to help you deal with the post-agreement issues that are critical to your future.

3. GOVERNANCE TOOLS NEW

Come and learn at least ten tools that you can use to contribute to successful governance in your housing co-op. From a meeting agreement, to a member satisfaction survey, an annual calendar to a good governance test - we have tried and tested tools to share!

6. SUBLETS, ROOMMATES, VISITORS, OVER-HOUSING AND MORE! NEW

Our expert team of co-op lawyers is back! We'll focus on Occupancy Agreement 2.0 and your questions on over-housing, sublets, roommates, Airbnb, smoking, home businesses and more if time. This could be your turn to win the prize for the toughest question.

Looking Inward, Looking Outward

Keynote speaker: Derek Ballantyne – CEO of Encasa Financial Inc. and incoming Chair of the CMHC Board of Directors

Where does co-op housing fit in a discussion of the most promising solutions to the current housing crisis? Are there opportunities to increase our impact here in Canada's most expensive housing market? Derek will share his insights on provincial and national housing policy and challenge us to think about our role.

7. CANNABIS IN CO-OPS UPDATED

New federal legislation regarding growing and using cannabis comes into effect soon. Learn about the main issues for housing co-ops like electricity consumption, unit damage, users with disabilities and how to balance the rights of cannabis consumers with those of non-consuming neighbours.

8. HOLDING FRIENDS ACCOUNTABLE NEW

No one follows through on their commitments every time, but what is it that makes us want to? Co-op culture can encourage or discourage accountability. Come find out how friends and neighbours can hold each other accountable, without naming and shaming.

9. ELECT THE BEST DIRECTORS - EVERY TIME! NEW

Electing good and effective directors is the most important role that members have in governance. We'll explore tools and techniques to elect the best directors as well as new provisions in Model Rules 2.0 that leave little to chance and seriously up your game before, during and after election night!

10. ORGANIZE IT! UPDATED

Get your office in order and make your documents live again. Gain an understanding of what records are meaningful, useful and legally required as well as ideas for reviewing and reorganizing your co-op's documents. Capture the stories they tell, the histories they record, the important decisions and milestones they contain.

11. MENTAL HEALTH AND YOUR CO-OP COMMUNITY UPDATED

Better understand mental health and how to support those living with mental illness, including how to engage appropriate support services. Examine the co-op's responsibilities and gain clarity about the legal issues, so you can balance the best interests of the co-op with the needs of individual members.

12. FILLING THE GAPS NEW

As co-ops consider future operations, the issue of potential loss of subsidy is a critical factor. We'll review what's involved with contemplating an internal system of support for lowincome households: what financial and policy elements need to underpin an independent approach to support?
