1. Call to Order and Introductions

The meeting was called to order at 7:01 p.m. by the chair, Avis Michalovsky.

2. Acknowledgement

The chair acknowledged that the meeting is being held on the traditional territories of Vancouver Island's First Nations.

5. Business Arising

There was no business arising from the minutes.

6. Report from CHF BC Board

CHF BC directors Shannon Sangster and Dave Maier shared highlights from the last quarter, including efforts to influence public attitudes toward affordable housing during the federal election campaign, new Community Land Trust developments, and CHF BC's upcoming annual general meeting.

Dave Maier advised that he would not be seeking re-election to the board as a Vancouver Island director. He thanked delegates for their support over the years.

7. Member Services Report

Michelle Cooper-Iversen reviewed events and workshops offered through CHF BC's education program, highlighting the upcoming Well-Being Conference. Michelle reported that the co-op services team is busier than ever, responding to an average of 140 calls/month. Finally, she announced that the Island waste management contract had been retendered and awarded for a new three-year term to GFL Environmental Inc. Prices under the program will be frozen for three years, delivering impressive savings to members.

8. CHF Canada Report

CHF Canada director-at-large Anne Davidson reviewed the highlights of the 2021 Annual General Meeting, and announced that the 2022 AGM will be held in Halifax in person, June 16-18. She ended her update highlighting the success of the "Vote Housing" campaign during this year's federal election and urged delegates to visit www.votehousing.ca/reaction for more details.

9. Elections

Thom Armstrong introduced the elections for Island Council chair and vice-chair. He declared Avis Michalovsky from Pioneer Housing Co-op acclaimed to the position of Council chair for a one-year term. There were no nominations received for the position of vice-chair by the deadline.

Armstrong then introduced the election of a Vancouver Island Director. He declared cclaimed Art Farquharson from Seawalk Housing Co-op acclaimed to the position of Vancouver Island Director for a two-year term.

10. Other Business
