- 2. Any received grant funds will only be spent on the project described in this application.
- 3. Your co-op will not use the CHF BC Sustainability Grant funds to pay for any work carried out before CHF BC has reviewed or approved your grant application.
- 4. The project will be completed within the timeframe described in the application. Any extension of deadlines will be at CHF BC's sole discretion.
- 5. Your co-op will send to CHF BC a quarterly project report, along with expense receipts and pictures/video, as it reaches each milestone set out in the application.
- 6. Your co-op will send to CHF BC a final report once the project, as described in the application, is complete.
- 7. You agree to sign a letter committing to the terms of the CHF BC Sustainability Grant.
- 8. CHF BC reserves the right to share any documents or photographs submitted by your co-op to share with CHF BC member co-ops or for external reporting purposes.
- 9. Your housing co-op will be solely responsible for any continuing costs arising from the project and any costs arising if the project fails or is not completed as described in the application.
- 10. CHF BC can cancel the approved grant and recover any funds paid out if it learns that the project was not as described or was not completed.
- 11. CHF BC reserves the right to accept or reject any or all applications. It may reject any application which fails to meet application eligibility or other requirements associated with the Sustainability Grant. No housing co-operative or its representatives shall have any cause of action against CHF BC arising out of a failure to consider awarding the grant, or the methods by which applications are used or assessed, or the methods by which a final application may be selected or awarded.
