The Co-op is a smoke-free housing co-op. It is a material term of the occupancy agreement that smoking is prohibited everywhere on co-op property and in proximity to it, including but not limited to all homes, common areas, hallways, balconies, and patios. This applies to members and guests. "Smoking" includes vaping and the inhaling, exhaling, burning or ordinary use of any tobacco or other product whose use generates smoke. *

 - o Income source(s)/pay stubs for the last three (3) consecutive pay periods

- Employment letter or permission to contact employer for income details OR
- o Three (3) months' recent bank statement indicating regular income deposits, with all expenses blacked out

Note: Additional documentation may be requested for the purpose of income verification, including consent for a credit check Qualifications
